## **Change in Lot Size from 100 MMBtu to 50 MMBtu and Tenure of Week-4 Contract**

---

Dear Members,

In pursuance to Byelaws and Market Rules of IGX, Members are requested to kindly note that from Trade Date 24<sup>th</sup> May 2021, IGX will be making following changes in the lot size of the contract and Weekly contract:

- 1. Change in Bid Lot Size:** From 1 lot = 100 MMBtu to 1 lot = 50 MMBtu. Each lot will signify 50 MMBtu and Members can place their bids in multiple of the lot size. For e.g. If a buyer/seller wants to buy/sell 250 MMBtu then he will place 5 lots at the time of bidding. This change will bring more flexibility to smaller gas buyers and sellers to better manage their gas requirements.
- 2. Tenure of Last Week Contract of a Month:** Currently last weekly contract of the month signifies delivery period from 22<sup>nd</sup> to 28<sup>th</sup> of each month. Henceforth, the last Weekly contract will signify delivery period from 22<sup>nd</sup> to **end of the month**. For e.g. For 4<sup>th</sup> Weekly contract of June month, the delivery period will start from 22<sup>nd</sup> June and end on 30<sup>th</sup> of June. There will be no other changes in the contract specification of Weekly contracts. The above change in the Weekly contract will be effective from the month of June 2021.

In reference to Trading and Settlement calendar vide Circular No. 32, the trading timetable of Weekly Contract will be changed as mentioned in Annexure- I below.

This Circular will come into effect from Trading date 24<sup>th</sup> May 2021.
